- **4.** Our limousines cannot be loaded beyond their capacity.
- **5.** In case of blatant indiscretion on the part of the client and/or any member of their party, the driver has the right to terminate the service without a refund.
- **6.** Victoria Limousine, Co is not responsible for any articles left in the vehicle.
- **7.** Victoria Limousine, Co is not responsible for delayed travel time due to unforeseen weather, traffic, road conditions or delays beyond our control.
- **8.** Victoria Limousine, Co is not liable in the event of a mechanical brakedown of the vehicle during service and will only be responsible for making up lost time or service at mutually agreed date and time.
- **9.** Victoria Limousine reserves the right to substitute a vehicle of equal or greater value in the event of mechanical difficulties.
- 10. Cancellation must be received 48 hours prior to scheduled pick up time to avoid charge.
